Revised Duration of Enrollment Validity (N+2) as per UGC Guidelines w.e.f. the academic year 2016-17

As per the Notification: 1/2012, the validity of student's enrollment in particular course was declared as double the duration of a particular course duration.

However, as referred in the above UGC letter & Guideline, it is declared to consider and pursue the form of N+2 as normal span period within which a Student may be allowed to Qualify for a Degree. Where N stands for Normal or Minimum duration and 2 stands for granting two more academic years prescribed for completion of degree. This revised duration of Enrollment Validity is applicable W.e.f. Academic Year 2016-17.

In exceptional circumstance, a further extension of one more year may be granted. In this regards, if a student is not in a position to complete the course within the duration specified (i.e. N+2), and if further time is required beyond the extended period, he/ she will be required to submit an application as an exceptional case to Honorable Vice Chancellor stating reasons for granting the extension.

In this regard for exceptional cases, "If all the academic terms of the applicant student required for the completion of the course are granted and previous backlog of the student are pending within the span of period of N+2, in such case, if student is seeking extension immediately after the expiry of the N+2 period for the completion of the course as per GTU norms and the student has continuously appeared in last two consecutive exams for all the subjects for which the student has backlogs then in such case he/she will be eligible to get extension of 1 year (maximum two exams). The application for reenrollment shall be submitted through college to GTU latest within 1 month of the commencement of the academic year with the due payment of re-enrolment fees of Rs 1500.

However if student has not appeared in last two consecutive exams for all the subjects for which the student has backlogs due to unavoidable circumstances like critical illness or sad demise of his/her guardian (father/ mother) or others as found to be justified by the University, he/she may be granted the extension of 1 year (maximum two exams) after due payment of re-enrolment fees of Rs 5000.

If the student has not appeared in last two consecutive exams for all the subjects for which the student has backlogs without any valid reasons he/she shall not be eligible for further extension."

The extension of enrolment tenure is only granted to the students to appear in the exams to clear the backlogs after the expiry of the validity of the enrolment term if all the terms have been granted.

Honorable Vice Chancellor is sole authority for granting of extension of enrollment period. It may be noted that such applications must be submitted 30 days before the commencement of the next University examination.
